

GOLDEN RETRIEVER RESCUE OF NORTH TEXAS

FOSTER AGREEMENT

RE: Golden Retriever known as (Name/GRRNT #) _____

I acknowledge that GOLDEN RETRIEVER RESCUE OF NORTH TEXAS ("GRRNT") is the sole owner of the dog described above, hereinafter referred to as "THE DOG."

Because I wish to assist GRRNT in its efforts to rescue dogs of the Golden Retriever breed and arrange suitable permanent homes for these dogs, I do hereby willingly volunteer to provide a foster home for THE DOG, for a time period as agreed between me and GRRNT (hereinafter, "the foster period"), so that GRRNT can make suitable arrangements for the permanent adoption of THE DOG. During the foster period, I will keep THE DOG at my home at the address shown below, and will provide food and shelter for THE DOG at no cost to GRRNT. I will provide prior notice to an officer of GRRNT before changing my home address during the foster period. I will not obligate GRRNT to pay any cost associated with the care of THE DOG, without first obtaining approval from an officer of GRRNT.

I will call an officer of GRRNT if THE DOG should need to see a veterinary doctor during the foster period, and will obtain prior approval before taking THE DOG to a doctor. In case of medical emergency, and only if I cannot contact a GRRNT officer for prior approval, I will take THE DOG to a licensed veterinary doctor for emergency treatment, and GRRNT will pay reasonable costs associated with that treatment. If THE DOG is required to have medication during the foster period, I will administer such medication pursuant to instructions provided by a veterinary doctor and/or GRRNT, but only if GRRNT provides and pays for the medication.

When notified by GRRNT to do so, I will give up possession of THE DOG to an officer of GRRNT for permanent adoption. In the meantime, should I elect to adopt THE DOG, I will promptly submit a completed GRRNT Adoption Agreement and pay the standard adoption fee of \$425 (dogs 0-12 months), \$375 (dog 1-7 years), or \$200.00 (dog 8 years and older). Should I need to terminate the foster period earlier than the agreed time for any reason, I will give reasonable notice to GRRNT so that they can make alternative arrangements for THE DOG's care.

GRRNT will provide a list of officers and their phone numbers, who may be contacted for any approval that I may be required to obtain or notice that I may be required to provide pursuant to this Foster Agreement.

From time to time, GRRNT may request that I foster another dog or other dogs. I hereby agree that, execution of a separate Foster Agreement will not be necessary for future foster arrangement(s) that I may volunteer to provide to GRRNT, and that I will comply with the terms and conditions of this Foster Agreement in any such future arrangement(s).

While every effort is made by GRRNT to provide accurate history and assessment of THE DOG, GRRNT does not warranty or guarantee THE DOG's medical status, behavior or disposition.

I understand that GRRNT is not responsible for any damage to persons or property associated with my providing foster care for THE DOG pursuant to this Foster Agreement. I hereby release, indemnify and hold harmless GRRNT, its officers and members, their heirs, administrators, executors, successors and assigns, from any and all liability of any and every nature and cause, directly or indirectly relating to THE DOG, and particularly on account of my providing foster care pursuant to this Foster Agreement.

I have read and understand all the terms of this Foster Agreement. By signing this Foster Agreement, I agree to abide by all its terms and conditions. I am signing this Foster Agreement of my own free will, and am not under duress of any kind. I have never been charged or ticketed with cruelty to an animal.
