All Animals MUST be Neutered/Spayed, current on ALL vaccines and free of Internal and External Parasites.

Owner will contribute to GRRNT a sum equal to \$25 per night, per dog, for the service provided pursuant to this agreement. For GRRNT members and Foster To Adopt a \$5 per night per dog discount will be given. Full payment is due upon execution of this agreement. Owner will furnish a sufficient supply of food for THE DOG, and any medication that THE DOG is scheduled to take during Owner's absence.

During the time THE DOG is a guest in Sitter's home, Sitter will provide shelter and reasonable exercise for THE DOG, and will feed THE DOG and administer medication in accordance with Owner's instructions and using the food/medication provided by Owner. If in Sitter's judgment, THE DOG requires medical attention, Sitter will attempt to reach Owner at the numbers provided below. If Sitter cannot reach Owner, Owner hereby authorizes Sitter to obtain medical care, including tranquilization if necessary, from any licensed veterinary doctor, and Owner will reimburse Sitter for all reasonable costs associated with such treatment. Owner hereby authorizes the veterinary doctor identified below, to release THE DOG's medical records to Sitter upon request.

Owner will pick up THE DOG on the date indicated above. If for any reason Owner is delayed, he/she will provide notice to Sitter of the delay as soon as is reasonably possible. If Owner fails to provide such notice and if THE DOG has not been claimed within seven (7) days of the originally scheduled pick-up date, Owner relinquishes all rights and ownership of the dog to GRRNT forever, and GRRNT will arrange for THE DOG to be adopted by other permanent owners

GRRNT is not responsible for any damage to any persons or property associated with the services provided pursuant to this agreement. Owner hereby releases, indemnifies and holds harmless GRRNT, its officers, directors and members, their heirs, administrators, executors, successors and assigns, from any and all liability of any and every nature and cause, directly or indirectly related to THE DOG, and particularly on account of the providing of services pursuant to this agreement by its member(s).
